TERMS AND CONDITIONS

- 1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Any entry which does not comply with these Terms and Conditions is invalid.
- 3. The Promoter is CNW Pty Ltd (ABN 48 009 669 836) of 675 MacArthur Avenue Central, Pinkenba QLD 4008, telephone: (07) 3907 8388.
- 4. Entry is only open to Australian businesses with a valid ABN (each an "Eligible Business").
- 5. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

- 10. Eligible Businesses must have a CNW account and must not have any outstanding charges in order to claim a prize.
- 11. Eligible Businesses must retain their original purchase receipt(s) and/or invoice(s) for all entries as proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoter, result in invalidation of ALL of an Eligible Business' entries and forfeiture of any right to a prize. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
