

## Sherriff Electrical – Win a Bluetti Power Station

### TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Any entry which does not comply with these Terms and Conditions is invalid.
3. The Promoter is Sherriff Electrical Pty Limited (ABN 63 010 059 837) of 675 MacArthur Avenue Central, Pinkenba QLD 4008, telephone: (07) 3907 8388 (“Sherriff”).
4. Entry is only open to Australian businesses with a valid ABN holding an active account with Sherriff (each an “Eligible Business”).
5. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, stepbrother, stepsister or first cousin.
6. Any Eligible Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion.

9. To be eligible to enter via the spend entry method, an authorised representative on behalf of an Eligible Business, must meet the following criteria during the Promotional Period (collectively referred to as a “**Qualifying Transaction**”):

10. “**Eligible products**” are Haneco products purchased through Sherriff.

The Eligible Business will be required to provide their contact details (including but not limited to the authorised representative’s full name, telephone number, email address and ABN for the Eligible Business) to the staff member for the purpose of the eligible business to claim the applicable prize.
