#### TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Any entry which does not comply with these Terms and Conditions is invalid.
3. The Promoter is Sherriff Electrical Wholesalers (Australia) Pty Limited (ABN 63 010 059 837) of 675 MacArthur Avenue Central, Pinkenba QLD 4008, telephone: (07) 3907 8388.
4. Entry is only open to Australian businesses with a valid ABN (each an "Eligible Business").
5. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.

12. The Eligible Business will be eligible to receive an E-gift card in accordance with the applicable Qualifying Transaction.
13. The redemption of the E-gift card will take place at the store in which the original purchase has been made after the claim has been validated. An E-gift card will be issued within four weeks of the purchase. The promoter reserves the right to request winners to provide proof of identity and/or proof of entry validity in order to claim the gift.
14. Eligible Businesses must retain their original purchase receipt(s) and/or invoice(s) for all entries as proof of purchase.
